LMSC PACKAGING STANDARD

IDENTICAL PARTS INTERLEAVED IN NEUTRAL/GREASEFROOF PAPER/PLACED IN A BOX

1.0 SCOPE

This standard provides a method for the packaging of multiple items within a box, separated by interleaving material.

3.0 REQUIREMENTS

3.1 GENERAL

- 3.1.1 Unless otherwise specified, the quantity per unit package shall be in accordance with the contractual document.
- 3.1.2 Material used for interleaving shall not degrade or cause commodity deterioration during shipment or storage.
- 3.1.3 Items coated with lubricants, transferable film or other coatings which may be absorbed through wicking action shall be interleaved with greaseproof/plastic material.
- 3.1.4 The interleaving material shall completely cover the item(s) to avoid any metal-to-metal, et al., contact.
- 3.1.5 Exposed silver or silver–plated parts shall be protected with tarnish–inhibitor material. Minimum surface area of the tarnish inhibitor shall be twice the area of the silver surface of the item.

NOTE: The treated side of the inhibitor material must be facing the item.

CAUTION: ITEMS HAVING ANY SURFACES INCOMPATIBLE WITH THE TARNISH INHIBITOR SHALL BE COMPLETELY WRAPPED WITH A NEUTRAL MATERIAL PRIOR TO APPLICATION.

- 3.1.6 Tarnish inhibitor may be adjacent to but shall not be allowed to come in contact with chemically finished surfaces such as anodize, iridite, chromate coatings and other nonferrous metals (e.g., cadmium, copper and brass).




Figure 1. Items with Individual Interleaving




Figure 2. Items with Continuous Interleaving

- 3.1.7 The interleaving method may be accomplished by individual cut sheets interleaved between each item (Figure 1), or with a single sheet interleaved between item(s) (Figure 2).

3.2 <u>UNIT PACKAGE</u>

- 3.2.1 Protect items in accordance with Paragraph 3.1.7.
- 3.2.2 Interleaved items may be bundled in multiple uniform quantities and secured with tape.
- 3.2.3 Insert items into appropriate size and type of container(s) to protect items during handling/shipment (Figure 1 and Figure 2).
- 3.2.4 Fill all voids with suitable dunnage.
- 3.3 <u>INTERMEDIATE PACKAGING</u> (Consolidation of unit packages, when applicable)
 - 3.3.1 Unless otherwise specified, the <u>number</u> of unit packages per intermediate container (containing identical parts) shall be limited to the dimensions and gross weight provisions of the container specification (Ref Carrier Regulations).
 - 3.3.2 Fill all voids with suitable dunnage, blocking or bracing, to prevent damage during handling/shipment.

3.4 PACKING

3.4.1 Pack appropriate number of intermediate containers uniformly into each shipping container.

- 3.4.2 Shipping containers as packed, shall protect the item from damage during ordinary handling/shipping and shall meet the minimum requirements of common carriers for safe transportation at the lowest rate to the point of delivery (see contractual document).
- 3.4.3 Unit or intermediate containers which meet the requirements of Paragraph 3.4.2 may be used as shipping containers.
- 3.4.4 Enclose or attach a copy of packing slip to the shipping container.

3.5 MARKING

- 3.5.1 <u>Unit Package Marking</u> Label or mark each package to show at least the part number per contracting document, quantity and supplier identity. Packages containing tarnish inhibitor shall be marked/labeled: "Protected with Tarnish Inhibitor Do Not Open Until Ready for Use or Inspection." Additional markings may be specified in the item detail specification or drawing.
- 3.5.2 <u>Intermediate Packaging Marking</u> Label or mark each container to show at least part number per contracting document, supplier and quantity of parts.
- 3.5.3 <u>Shipping Container Marking</u> Label or mark each container to show part number per contracting document, the LMSC contracting document number, supplier, destination and quantity of parts.
- 3.5.4 Apply special handling and precautionary markings as required.

4.0 QUALITY ASSURANCE

4.1 Packaging shall be accomplished in such a manner as to prevent physical damage to, or degradation of, the packaged items during delivery to the using activity. It shall be the prerogative of LMSC to return damaged items, at supplier's expense, when such damage is attributable to improper or inadequate protection.

5.0 NOTES

- 5.1 The following information is intended as a guide or aid to suppliers in meeting the requirements of this specification.
 - 5.1.1 <u>DEFINITION</u> <u>Unprotected Silver Surfaces</u>. All metallic silver surfaces (having stringent reflectivity or conductivity requirements, close–tolerance finishes and/or dimensions, without supplementary tarnish–resistant treatment), the deterioration of which may result in premature failure or malfunction of the item or equipment having such surfaces.
